#### 1. About Duty of Candour (definition)

The organisational duty of candour provisions of the Health (Tobacco. Nicotine Etc. and Care) (Scotland) Act 2016 and The Duty of Candour Procedure (Scotland) Regulations 2018 set out the procedure that organisations providing health and social care services and social work services in Scotland are required by law to follow when there has been an unintended or unexpected incident that results in death or harm (or additional treatment is required to prevent injury that would result in death or harm.)

Enabling and managing risk is a central part of delivering high quality health and social care services. Candour promotes responsibility for developing safer systems, better engages staff in improving services and creates greater trust in people who use these services, either firsthand or on behalf of someone else. Personalised discussions and communication, review processes that take account of what matters most to those affected and supportive responses following an unintended or unexpected incident all help to support and promote a culture of learning within the organisation.

Putting people at the centre of organisational responses to unintended or unexpected incidents resulting in death or harm also helps create the conditions where people feel psychologically safe to contribute to such discussions. Social Care Alba is committed to providing a truly personalised organisational response when things go wrong which requires a commitment to the provision of support and training for everyone involved in meetings, reviews and actions arising from a duty of candour incident.

### 2. About the organisation (history/background)

Social Care Alba was established in 2010 and was registered to provide Care at Home and Housing Support services. We currently work across the City of Edinburgh and have been the City of Edinburgh's Partner Provider for over 10 years. We provide a range of services to people from social visits to 24-hour care.

#### 3. Incident Reporting

All Health and Social Care providers in Scotland must provide an annual Duty of Candour report for their services. During this reporting period no incidents have triggered the Duty of Candour procedure.
